SAMPLE PRINT-ON-DEMAND PUBLISHING AGREEMENT

This Agreement is being made on 9th December, 2011 between **Equilibrium Books®** and **Mr Author** herein referred to as "Author." This is an agreement regarding the print version **ONLY** of "My Book Title" herein referred to as "Work." This Agreement will expire one (1) **year / two (2) years** from the date of this Agreement.

In consideration of the mutual terms, conditions and covenants set forth herein, the Author and Equilibrium Books agree to the following:

1. The Author warrants that he/she is the exclusive owner of said Work, and has the legal authority to enter into this agreement and grant publishing rights in respect of the Work. Furthermore, the Author states that the Work is free of any counts of libel, copyright infringement, plagiarism, misrepresentation of facts or breach of privacy. The Author also warrants that the Work (including all submitted artwork) is completely original (or that the Author has license to use such content), is not in public domain and has not been published in paperback or electronic form under a contract that would conflict with this Agreement. The Author also guarantees that he/she is the sole owner of the copyrights of the Work and assumes all responsibility for the authenticity of the copyright of the Work. The Author undertakes not to enter any agreement with any person, firm or corporate entity that would conflict with the rights hereby granted to Equilibrium Books.
2. The Author releases Equilibrium Books from any legal actions that may arise from the Work. The Author will hold Equilibrium Books and its distributors harmless against legal actions that may arise from plagiarism, breach of privacy, misrepresentation of facts, and the authenticity of the Work or copyright infringement. The Author will also pay any and all legal fees, associated costs and determinations that result from such a suit.
3. This Agreement may be terminated at any time and for any reason by either Party provided that 90-days written notice is given to the other Party via registered mail. In the case of termination of this Agreement for whatever reason, the Author shall forfeit all monies paid by the Author to Equilibrium Books and have no further claim on Equilibrium Books save for any unpaid royalties due.
4. The Author agrees to furnish Equilibrium Books with any materials required for publicity purposes, including reviews, photos, summaries, etc. The Author also agrees that Equilibrium Books has the right to use his/her name and likeness for any and all promotional purposes during the term of this Agreement. Equilibrium Books also has the full right to use book excerpts, quotes, reviews, cover images, etc. for promotional purposes.

5. The Author assigns to Equilibrium Books, Print-on-Demand rights only and appoints Equilibrium Books as its Print-on-Demand distributor for the length of this Agreement. Author agrees **not** to enter into any Contract or Agreement with any other **Australian** Print-on-Demand company or organization until the expiration of this Agreement. Author retains all other rights to the Work.
6. Equilibrium Books does not guarantee any volume of sales for the Work. Equilibrium Books will pay the Author royalties based on a flat rate of **13.5%** of the actual sale price per copy (retail, wholesale, or sales made to the Author etc.) less any returns or disputes from any internal or external sales, and less Australian Taxation Office Withholding Tax for non-residents of Australia, where applicable. Royalty is not paid on shipping and handling charges. All royalty payments will be paid to the Author at the end of each quarter, provided accrued royalty amounts are **AUD\$20.00** or more.
7. For the duration of this Agreement, the Author has the right to purchase additional copies of the printed Work at a maximum discount of **30.75%** (**22.5%** for OZ POD Bronze Packages) off the Work's cover price. **All purchases by the Author must include all applicable shipping and handling costs (plus insurance costs if required by either party). Full payment in advance is required. (Minimum purchase requirement of 25 copies of the Work at cover price less 22.5% discount for OZ POD Bronze packages.)**
8. Equilibrium Books may make reasonable changes, additions, deletions or condensations to the Work **with** the consent of the Author.
9. Author agrees to pay Equilibrium Books a one-off fee for service of **AUD\$ (Relevant OZ POD service fee – Not applicable to OZ POD Bronze packages).**
10. Author may renew this Agreement after its expiration for an additional fee of **AUD\$25.00 / AUD\$50.00** per annum. **(Not applicable to OZ POD Bronze packages. Renewals subject to acceptance by ALL parties.)**

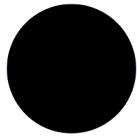

The Author assigns to Equilibrium Books, non-exclusive electronic rights only, and grants Equilibrium Books the right to publish and distribute the Work in **Kindle** electronic digital format, to be sold and distributed by Amazon Digital Services. No ISBN will be issued for a **Kindle** eBook edition. Author agrees **NOT** to offer for sale any other Kindle eBook Edition of the Work for the duration of this agreement.
6. Equilibrium Books does not guarantee any volume of sales for the Work. Equilibrium Books will pay the Author **50%** royalties based on net returns from the sale of the Work, which equal the payments Equilibrium Books receives, less any production costs, taxes or fees, credit card charges, discounts or disputes from any internal or external sales, and less Australian Taxation Office Withholding Tax for non-residents of Australia, where applicable. Any royalties due will be paid to the Author upon receipt of payments from Amazon Digital Services, via EFT or PayPal only.
7. Equilibrium Books may make reasonable changes, additions, deletions or condensations to the Work to prepare it for the **Kindle** format, **with** the consent of the Author.
8. Author agrees to pay Equilibrium Books a one-off fee for service of **AUD\$ Applicable Package Fee** (Kindle eBook Package or Add-on).
